- Actively forms relationships and partnerships which advance ACT Alliance and the ecumenical movement's agenda
- Supports and enables ACT members collaboration in key transformative development policy issues including Agenda 2030 for sustainable development, religion and development, development effectiveness, financing for development and gender and in implementing the ACT global advocacy strategy
- Represents the ACT Alliance towards the New York based United Nations institutions and other partners
- Supports relevant Secretariat colleagues in wider advocacy issues relevant to UN and other audiences, eg: humanitarian advocacy
- Develops partnerships and fundraises for joint member-led initiatives
- Advises ACT's development policy and advocacy agenda, and in coordination with the Global Advocacy and Policy Coordinator supports the implementation of the global advocacy strategy
- Implements programmes and projects with the ecumenical and other partners to advance the ACT Alliance sustainable development agenda
- Communicates with members, partners and relevant institutions on ACT Alliance engagement in sustainable development
- Advises and supports ACT Regional Representatives on development policy issues relevant to their regions
- Supports the General Secretary, Director and Head of Strategy and Partnerships in external representation, as required
