# **Details of Response**

**Emergency: Floods and Landslides in Sri Lanka** 

Date of Emergency: 27<sup>th</sup> May 2017

ACT Requesting Member(s): The National Christian Council of Sri Lanka

# I. NARRATIVE SUMMARY DETAILS OF THE EMERGENCY

Incessant heavy monsoon rains (as high as 553 mm) starting on May 26 have caused floods and landslides in many parts of Sri Lanka (15 districts). As of 1<sup>st</sup> June 2017, 206 people are reported dead, while 92 are missing; so far, over 658,490 people are affected. Further, 1,713 houses were fully destroyed and around 9,294 houses partially damage<sup>1</sup>. Most number of damages to lives and property are reported in Southern and Western part of the country: from Galle, Matara, Kalutara, Gampaha, Colombo and Ratnapura districts. In addition, Approximately 68,734 people were relocated to 365 safe locations.

Further warnings possible on bursting of dams and over flow of rivers and reservoirs have been issued, while the National Building Research Organisation (NBRO) have requested persons living in areas of Kegalle, Matara, Hambatota Nuwara Eliya and Ratnapura to move to safer locations. In addition, the depression in the Bay of Bengal aggravated the situation especially in the south western parts of the country.

### **ACTIONS TO DATE, AND EMERGENCY NEEDS**

The government of Sri Lanka, through its chain of government officials, the Police, Army and Naval forces are working in the affected areas. In addition, the Ministry of Foreign Affairs in coordination with the Ministry of Disaster Management, has made an appeal to UN, International Search and Rescue Advisory Group (INSARAG) and neighbouring countries to provide assistance to affected people. India has already started providing support to Sri Lanka.

The disaster response teams at the ground level have been working continuously in providing the assistance to the affected communities. ACT Sri Lanka Forum through NCCSL has shared the information of this disaster to ACT Alliance members and taken a humanitarian action already. NCCSL is now working with the government authorities, churches, and inter-faith partners in providing cooked food and lifesaving assistance for the affected population. According to the needs of the affected population, NCCSL plans to work on the following sectors: Food Security, Non-Food items, Health and WASH.



#### PROPOSED EMERGENCY RESPONSE

#### **OVERALL GOAL:**

To provide life-saving food and packages to affected people, and improve their access to life-saving health services.

## **OBJECTIVE(S) OF THE EMERGENCY RESPONSE:**

- 1. To provide 4,000 packets of cooked food to affected population
- 2. To provide 1,160 dry ration packs to 1,160 households
- 3. To provide 500 packs of kitchen utensils to 500 households
- 4. To complement the health assistance in the existing medical camp by providing financial support for some medical equipment.
- 5. To facilitate the access to drinking water and clean bathing wells in areas affected by floods

#### **PROPOSED ASSISTANCE:**

#### Food Security

- 1. To provide/facilitate 4,000 packets of cooked food to persons affected by floods: Supplying meals to persons directly affected by floods and are unable to cook and support themselves. In most cases the cooked food will be provided to persons camped in schools, Churches and other community centres (meals will be Sri Lanka's of staple meal of rice with basic accompaniments)
- 2. To assist 1'160 households to return to normalcy in their daily lives by providing 1'160 packs of dry ration packs: The dry ration packs will consist of rice 5 Ks, sugar 2Kg, tea leaves 500g, dried sprats 250g, dhal 1Kg, Canned fish 2 tins, onion, garlic, chilli & curry powder, salt, soy meal 1 pkt, chick peas 1Kg, wheat flour 2 Kg.

## Non-Food Items

3. To provide 500 Kitchen utensil packs to households, so that they could return to normalcy: The kitchen utensil packs will contain pots and pans, jugs, kettles, buckets, water pots etc.

### Health

4. To complement the health assistance in the existing medical camp by providing financial support for some medical equipment. Teams in medical camps are composed of professional doctors, who would treat the affected people of viral infections, cuts, burns and other injuries.

### WASH

5. Facilitate the cleaning of drinking water and bathing wells in areas affected by floods, making it suitable for persons to consume.

#### **IMPLEMENTATION ARRANGEMENTS:**

Most of the programmes under this RRF will be implemented by NCCSL and its partners, Church of Ceylon - Diocese of Colombo, the Methodist church in Sri Lanka, the Sri Lanka Baptist Sangamaya, Church of Assemblies of God, and other inter-faith and secular organisations working with NCCSL.

The procedure will be as in previous instances. No MOUs have been signed for this program among NCCSL partners and networks, but NCCSL will be responsible for ensuring the quality and accountability of the program and the responses will be delivered with high international humanitarian standards. At the moment, NCCSL is working with the existing community based organizations in Galle and Ratnapura area to provide the assistance to affected population.

## **COORDINATION:**

The Social Responsibility Arm of each church will be responsible for implementing the activities under this RRF and this body will play the coordination role with their local churches to deliver the humanitarian response to the affected communities.

NCCSL will also coordinate with the program stakeholders and will ensure that the program development and management are participatory and inclusive. NCCSL partner organizations recognised the importance of participation in the program implementation, they have therefore involved the rights holders in the existing humanitarian actions.

NCCSL will be responsible for program monitoring and ensuring that the uniformity and effective sharing of information among the diverse implementing partners in a specific region is in place.

The General Secretary and the NCCSL's Rehabilitation and Development Unit staff in Colombo office will coordinate and facilitate the initiatives through programme coordinators supported by the Executive Secretary who will be responsible for selecting the program areas in Nivithigala, Agalawatte, and Ehaliyagoda & Colombo. The clergy and the church leaders will be the focal points in implementing the activities.

The district level coordination is conducted by the respective clergy. NCCSL and the clergy will develop linkages with relevant government authorities and other stakeholders throughout the emergency response processes. In addition, the regular dialogue with the respective Divisional Secretaries and the Government Agents is needed. The communication initiatives of gathering, updating and sharing information will also be the key aspect of the process that will enable effective implementation initiated this with ACT Members.



Finally, NCCSL will coordinate with its constituencies to strengthen the implementation of this RRF program. NCCSL will have regular meetings with its constituencies to share information and resources. NCCSL will update the ACT Secretariat with regard to the implementation through ACT Alliance Appeal reporting system (Situation, Interim, Final and Audit reports)

#### **COMMUNICATIONS:**

The NCCSL and all the partner churches implementing this emergency response are well informed about the appeal and the need to share stories and lessons learned along the progress of implementation. The communications mechanism and skills, especially to issue stories that indicate the potential and achievements within NCCSL and their church and ecumenical organizations members is in place, while being strengthened as well. NCCSL communications will be taken into consideration during the organizational capacity assessment process to come up with practical recommendations. The NCCSL will be responsible for providing monthly situation reports and relevant pictures as the output of their regular monitoring visits.

#### **PRINCIPLES AND STANDARDS:**

The implementation will follow a rights based approach and ensure that ACT policies and codes of conduct will be adhered to while ensuring the safety and protection challenges (including as per the child protection policy). Also, the Core Humanitarian standards, the Red Cross Code of Conduct and the do no harm principle will be applied throughout all phases of implementation. A mechanism will be put in place to capture any complaints, which would all be addressed.
