#### Section 2: Narrative Summary

## Background

Heavy rains caused by powerful tropical Cyclone Idai hit the central and northern regions of Mozambique from 14th March 2019, leading to massive floods and leaving at least 202 people dead, according to the President of Mozambique, Filipe Nyusi. The death toll is expected to rise in the coming days. The situation is likely to deteriorate and the number of people affected is likely to increase, as weather experts predict heavy rainfall in Sofala and Manica provinces from 19 to 21 March. Flood waters may rise up to around eight metres and at least 350,000 people are at risk (OCHA Flash Update, 19 March). There are also growing concerns regarding the potential effects of the overflow of the Marowanyati Dam in Zimbabwe on water levels in Mozambique.

Most of the affected population are located in the provinces of Zambezia (districts of Chiunde, Luabo, Inhassugue, Mopeia, Nicoandala, Maquaival, Mocubela. Mulevala, Mocuba, Milage, Dere and Qualimane), Niassa (districts of Cuamba and Madimba), and Sofala Province (districts of Buzi, Chemba, Caia, Cherigoma, Chibabava, Dondo, Gorongosa, Morremeu, Marrigue, Muaza amd Nhamantanda).

Based on initial assessments from ACT member Comité Ecuménico para o Desenvolvimento Social (CEDES)/Ecumenical Committee for Social Development, 683 of those affected in Zambezia by the floods have been identified as orphans and vulnerable children, and 165 have been identified as elderly. Moreover, 286 classrooms have been total destroyed forcing more 2,450 children out of schools. The damage to agricultural lands is also very significant, with at least 83,813 hectares of crops such as maize, cassava, sorghum and millets flooded, affecting 53,318 small farmers whose livelihoods depends on farm produce.

## **Humanitarian Needs**

CEDES, local churches and local authorities conducted a rapid assessment in the districts affected by the floods. The report revealed a dire situation that would need a multi-sectoral response to support the affected population. The affected people in the assessed regions have lost everything including homes, crops, and livestock. The community respondents identified that the priority needs are immediate safe drinking water; food; non-food items such as hygiene kits, kitchen kits, and candles. The priority will be at least 5,000 female-headed households (25,000 individuals) that also include



the elderly, sickly, and children. There is also a great need to provide emergency shelters (tents) for at least 500 families whose houses were completely destroyed in the districts of Caia, Cheringoma, Chemba and Chibabava and Nicoandala and Mopeia.

CEDES is a member of ACT Alliance and has been providing guidance in coordination and planning of emergency activities; providing training on disaster preparedness, response and mitigation. CEDES's recent emergency experience includes: Response to Drought in Southern Africa, MOZ161, and Response to flooding in Central and Southern Provinces, MOZ131. In the current situation, CEDES trained staff and local leaders are already on the ground leading in rescue operations and mobilizing relocation efforts. An Emergency Response Committee is established and is closely monitoring the situation in order to provide emergency assistance effectively and efficiently. CEDES is collaborating with Mozambique government and other stakeholders to respond in a coordinated way.

## **Proposed response**

This RRF will focus on Sofala Province (with a planned ACT Appeal to cover more areas), and will provide non-food items and food to 4,500-5,000 persons as follows:

Blankets to 4,500 HH, food to 5,000 HH and distribution of kitchen kits and plastic sheeting for 600HH as temporary reconstruction of homes for affected targeted HH.

Communities will be mobilized in order to create awareness on protection issues.

#### Monitoring and evaluation

CEDES will develop various tools to monitor the project activities on weekly and monthly basis of the relief distribution made to ensure that the support is reaching the most vulnerable people affected by the floods. The Project Manager together with the emergency coordinator will be responsible for data collection to measure progress made towards objectives, the quality of services provided, and the number of participants reached by awareness efforts. Monthly monitoring reports will be submitted to the ACT Alliance Secretariat.

## Section 3: ACT Alliance coordination

#### Coordination

CEDES will be coordinating activities on the ground along with local implementing partners. who will will help mobilize, raise awareness and educate people on hygiene to prevent diseases caused by water borne diseases. Emergency Response Committees will be involved in organizing volunteers and monitor implementation progress. They will meet every week to review project progress and propose adjustments if needed. Further, CEDES as a part of UN Clusters have been meeting regularly to share information and monitor the situation as it unfolds. The team is collaborating with Government, INGC, and other NGOs to ensure there is clear understanding of the emergency response.

#### Implementation arrangements

The CEDES Director General will be responsible for overall coordination and management of the 3-month project. On the ground, the Emergency Coordinator (EC) and Project Manager will be responsible for planning, implementation, management, monitoring and evaluation of the project, and the dissemination of learning. The EC will be supported by an emergency response specialist with technical expertise and will provide support on the ground. The CEDES finance officer at the provincial level will play a leading role in financial planning and management, including in processing claims and producing monthly financial reports.

A Project Steering Committee (PSC) will be formed to oversee the project's progress. It will comprise of the Emergency Committee, Representatives from the Floods Emergency Response Committee, Provincial Directorate of The National Disaster Management Institute (INGC), and Administrative Heads of the target districts and other Government Departments. The PSC will have a leading role in advising and ensuring proper implementation and monitoring of project activities.

Furthermore, 20 emergency assistants will be deployed and will assist in distribution of food and other items to the people affected by the floods.

### Human resources and administration of funds

Being an ACT member, CEDES staff involved in emergency response are required to sign the ACT Code of Conduct that mandates their expected behaviour in emergency response. This will be communicated to the affected communities. In addition, CEDES staff are already trained on minimum standards in humanitarian response. For the administration of funds, CEDES will form a committee comprised of the EC, Representative of Floods Emergency Response Committee, Provincial Directorate of INCG and Administrative officer in the target districts and other Government Department to ensure that funds will be utilize for their intended purpose and ensure transparency.

#### **Communications**

CEDES is in coordination with ACT Secretariat staff to provide communication materials (photos videos) from rapid assessments and implementation.
