ALERT EARTHQUAKE Actalliance

Bangkok, 1 October 2019

SITUATION

In the afternoon of Tuesday the 24 September 2019, the district of Bhimber, Mirpur and Jhelum in Azad Jammu Kashmir and Punjab, Pakistan, was badly struck by the Earthquake of magnitude 5.8 that killed 39 people (38 in Azad Jammu Kashmir and 1 in Punjab) injuring 746 others. 454 houses including 135 severely and 319 have been partially damaged. However, as per the visit of the affected areas and meetings with the communities by the field staff of ACTED, FAO, Muslim Aid and Islamic Relief, the unofficial findings estimated that around 9,000 families have been affected with 7,000 houses have been damaged in Mirpur district during this earthquake. Out of them, 1,000 have been either partially or fully damaged as confirmed by the Deputy Commissioner of Mirpur AJK. Aftershocks continued to rock the region, many left their homes and spent the night on the roadside or in parks. Infrastructure including houses, roads, mobile phone towers and electricity poles have been badly damaged and communication channel both through roads and telephones to some of the affected areas has been cut off. It is expected that the figures of damages and losses may be increased once the information from these inaccessible areas will be added.

NEEDS

The earthquake has put the district in a state of crisis. The earthquake affected persons find themselves in a desperate situation, with many unmet vital humanitarian needs such as access to food, shelter and household items, basic health services, and safe drinking water. Protection is an issue as well as people continue to live outside their houses fearing aftershocks.

The dire situation is further compounded for the earthquake affected people with vulnerabilities especially women and persons with disabilities, as they are the ones who are mostly affected with such disasters. Trauma is also a concern. In addition, women and girls' personal safety and security are at higher risk while homes are still damaged. There is a pressing necessity to provide immediate assistance to minimize loss of life and to ensure that the needs of the most vulnerable are covered first.

STAKEHOLDERS

The following national and international entities are present and doing their best to respond to the crisis:

Initially Army has started rescue and relief activities. Rescue operations have been almost completed while relief activities are underway. National Disaster Management Authority supported 500 families with tents, distributed 1000 food items and drinking water bottles, 200 kitchen sets and plastic mats. WHO has provided some medical assistance to the earthquake affected communities. ACTED has mobilized funds to support 1,000 families with cash intervention. Rest of the humanitarian organizations are assessing the situation and are planning to start assisting the communities.

Looking at the current response by the Government and pledges by other humanitarian agencies, there are still estimated 2,500 extremely vulnerable families who require immediate support for food, shelter, water supply and health services.

Based on its experience and presence in the area, Community World Service Asia (CWSA) plans to provide food and household items such as quilts and pillows as well as household repair toolkits to repair houses.

The emergency response is currently being coordinated by Deputy Commissioner, State Disaster Management Authority (SDMA) and National Disaster Management Authority (NDMA). To ensure that the humanitarian response is well coordinated and complementary, CWSA will take part in meetings with all relevant sector stakeholders (including government line departments, clusters, Working groups

and other coordination mechanism established for the earthquake response etc) and establish an open line of communication with crisis affected persons and communities to ensure a humanitarian response based on participation and feedback.
