Section 2 Project Description

2.1 Context

1. CHS Commitment 1. Summarize the crisis event and how it is likely to develop over the duration of the project (maximum 5 bullet points)

Massive floods devastated city of Jagodina in five waves, May 26th, June 2nd, June 3rd, June 12th and June 15th. On June 4th, City of Jagodina decalred state od emergency in it's entire territory

- So far, based on preliminary reports, more than 1,700 households is flooded in city area and in surrounding villages

- Massive rains and hail storms destroyed crops on an area of about 650 ha, mostly affecting wheat, corn, fruit and vegetable crops

- Damage was observed on the primary and secondary roads on the city's traffic network, on paved asphalt roads in the villages with a total length of about 240 km and and on uncategorized gravel roads in villages in total lenght of about 50 km

- Local infrastructure in the field of water supply and purification was damaged

- In Požega (Zlatibor district), the Moravica river overflowed, flooding households, crops and the industrial part of the town. The water is receding slowly in some areas, however certain areas are located on depressed ground, so in those areas the water will have to be pumped out. A number of houses are still only accessible by boat. Railway traffic was completely suspended.

- In Trstenik (Rasina district), massive rainfall caused the overflow of the West Morava River and flash floods. Residential and auxiliary buildings, as well as agricultural land, were damaged. Citizens report enormous material damage.

2. CHS Commitment 1,2,3,4. Explain the impact of the crisis specific to the people you want to help *(maximum 5 bullet points)*

The flash floods brought large amounts of mud into the flooded houses, left wet walls, destroyed furniture and electrical appliances that people could not protect. It will take some time to clean and sanitize the houses to make them livable again. In households where the crops are affected, the expected yield is destroyed, and as these households mainly live from agriculture, this can have major long-term economic consequences.

3. CHS Commitment 9. Explain the availability of funding each of your organisation can access for this crisis. (maximum 3 bullet points)

Philanthropy is in constant communication with its traditional partners: other ACT members and Catholic Relief Service. So far, financial support is provided from Diakonie ACT Austria.

EHO is in the process of consultation with international donors about posibilities for additional funds for this specific crisis.

2.2 Activity Summary

1. CHS Commitment 1, 2, 4. Explain your proposed project and why you have selected this particular response to the crisis. *If multiple members are responding, please explain the role of each member in the coordinated response as indicated in your EPRP Contingency Plan.*

Although there is a lot of damage to the traffic infrastructure, the market is functional, so the multipurpose cash assistance (MPCA) can meet most of the needs of the affected population, which are diverse.

EHO and Philanthropy will provide cash cards approx. value 200USD for 600 households in total. The cash assistance contributes 50% of total cost of the most urgent needs (food, medicines, toos, disinfection material, food for animals) of the people affected.

2. CHS Commitment 2. Explain how you will start your activities promptly. *Project implementation should start within two weeks. The project should be a maximum of 6 months.*

Immediately after the situation on the ground calmed down, Philanthropy staff conducted a needs assessment. In cooperation with stakeholders, criteria for the distribution of MPCA were formed. Philanthropy has a signed contract with Post office bank, which will issue cash cards for the population affected by the flood. Preparations for the distribution will be started as soon as the situation on the ground allows it. EHO already have great cooperation with all mentioned municipalities, due to realized projects in same. EHO already have contract with Post office bank, so fast response is ensured. Also EHO will coordinate work with Serbian Red Cross and Welfare centres in municipalities affected by the floods.

3. CHS Commitment 6. How are you co-ordinating and with whom? Coordination ensures complementarity of interventions within forum members and other humanitarian actors to maximise the use of our resources and will address all unmet needs

EHO and Philanthropy are closely monitoring activities of the other actors in Serbia and coordinating with them in order to avoid overlapping. Philanthropy and EHO are in ongoing communication and coordination from the beginning of crisis. Coordination among these two members is long-term one and responses will be divided geographically, according to the capacities and presence of each member. Coordination has been established as well with the government and local networks in order to facilitate the implementation. Philanthropy and EHO are in constant contact with representatives of the local authorities, the local center for social welfare, the crisis headquarters as well as other faith-based organizations, which ensures that all needs are met, as well as that there are no assistance overlapping.

EHO and Philanthropy have procurement policies. Decision on MPCA is made on the basis of existing damage and needs as well as functional market in affected areas.

2.3 Description of Target Population

According to statistics, the average family in the Republic of Serbia consists of 3,2 members, which roughly means that 2000 beneficiaries will be supported. During the distribution, Philanthropy and EHO staff will count the exact number of members of supported families, divided by sex and age.

The project has been developed after a consultation with the people living in the flood affected area to incorporate their needs. The project consistently aims to respect and reflect the needs and views of the vulnerable people serves. Regular field visits will be organized to adjust the project activities if needed.

The success of this project will be empowering the most vulnerable groups of affected populations in meeting their most urgent needs. Activities are as follows:

- Annunciation of dates of distribution of cash cards and information leaflets

- Distribution of cash cards and information leaflets

Philanthropy and EHO will develop Post Distribution monitoring tool and Philantropy and EHO staff will conduct interviews few weeks after distribution. ACT PME guidelines, principles and standard will be followed along with respective organizational policy for project planning, monitoring and evaluation plan design. Monitoring and evaluation will include field visits to follow up on the achievement of results and preparation of the situation report and final report.

The Project Coordinator will be responsible for project management and implementation, coordination and facilitation of the activities, monitoring, reporting and evaluation as well as for the promotion of the project on local and regional level and networking with different stakeholders.

Philanthropy has open and closed channels for FCRM (phone number, email address, KoBo questionary and face to face with staff). Philanthropy's staff is trained on Safeguarding principles and following SoP on handling sensitive and non-sensitive feedback.
