Advocacy group: a broader group of members led by the reference group that decides the annual advocacy calendar and priorities, and collaborate on implementation of joint advocacy activities. A global network

The Climate Justice Reference Group is composed of elected or nominated members. They work with the ACT Climate Justice staff in determining the vision and direction of the Climate Justice programme.

Working groups

Each group is co-chaired by one member from the global north and one from the global south.

Programmes group: a broader group of members led by the reference group that decides the annual calendar and priorities for integration of climate change in programmes. They collaborate on implementation of joint programme-related activities. This includes an annual Resilience Award for a project implemented by a member of ACT Alliance. Campaigns and Communication group: a broader group of members that decides the annual calendar and priorities for media and communications related to climate justice. This includes events, blogs, and social media in relation to the annual UN climate summits.

Primary member communication: email lists

During the year, all communication takes place through email lists. During specific events (such as the UN climate summit, known as a COP) WhatsApp groups are created. The following lists are available:

- Reference Group list only for members of the Climate Justice Reference Group.
- The Global Climate Justice list where all staff and volunteers of ACT members with an interest in climate change (advocacy or programmes) are welcome. Currently there are 250 members on the list. The list is mainly used for sharing information.
- The Climate Advocacy list Used by the members of the climate advocacy group for information and discussions.
- The Climate Programmes list Used by the members of the climate programmes group for sharing information and discussions.
- The Campaign and Communications list - Used by the members of the campaign and communications group for information and discussions.

Please note that Google Groups are used, meaning that it is best to use an email which is linked to a Google account. We need your written permission to add you to these lists, to comply with privacy laws.
